Notice Inviting Quotation

1. Introduction

Sagarmala Development Company Limited (SDCL) is a Central Public Sector Enterprise (CPSE) under the Ministry of Ports, Shipping and engaged in financing projects in the maritime sector.

Coastal areas have a unique and sensitive eco-system and communities have dependency on this eco-system. To strengthen and enhance the economic potential of these coastal communities, a **Coastal Community Development Fund** (CDF) is to be set up.

Under CDF, funds will be received by SDCL as a "Corpus Fund" from MoPSW, in 5 annual tranches of Rs 100 crores each. This shall be utilized for the welfare of the coastal communities by giving them financial assistance for enhancing their livelihoods. SDCL shall receive a fee for the management of the CDF.

To operate and manage the CDF, SDCL intends to engage the advisory services of a Financial Consultant.

2. Scope of Work: Development of Accounting procedure (based on Ind. AS, as applicable)

The Financial Consultant shall:

- a) Study the present accounting procedures of SDCL and advise the methodology for the CDF operation in SDCL considering the constraint that no separate entity is to be created for the same.
- b) Advise on the process to be adopted for receipt of funds, disbursement of funds and interest accrued from funds in the account, etc.
- c) Advise the accounting treatment of the management fee received by SDCL.
- d) Advise on the implication of PAN of SDCL being used in the bank account of CDF.
- e) Advise as to how to deal with the TDS on interest credited to the bank account, where SDCL's PAN is used.

3. Deliverables:

The key deliverable for this consultancy assignment shall be in the form of a report incorporating all the components mentioned in the above Scope of Work.

4. Firm Experience:

- a) The CA firm should have been in operations since the past 15 years, and
